Take a Bite Out of Your Bills Registration Prize Drawing

By participating in the Shark \$500 Registration Prize Drawing (“Drawing”) each participant unconditionally accepts and agrees to comply with and abide by these official rules (“Official Rules”). The decisions of Miami Dade College (“Sponsor”) shall be final and binding in all matters relating to this Drawing.

Entry to participate in the Drawing will begin at 12:01 a.m. EST on August 8, 2017 and will end at 11:59 p.m. EST on August 9, 2017 (“Drawing Period”).

- 1 Eligibility.** To be eligible for this Drawing, you must register for a minimum of one (1) credit-based course for the fall semester between 12:01 a.m. EST on August 8, 2017 and 11:59 p.m. EST on August 9, 2017 (“Entry Period”); you must remain enrolled as of the date of this Drawing, September 6, 2017; and you must comply with all eligibility requirements below. The Drawing is only open to Miami Dade College students who register for a minimum of one (1) credit-based course for the 2017-1 (fall term) and remain enrolled in a minimum of one (1) credit-based course as of the date the Drawing. All participants must be at least eighteen (18) years of age, legal residents of the State of Florida and able to provide a valid Florida-issued identification. By participating in the Drawing, each participant agrees that he/she has all rights necessary to enter and participate in this Drawing and grant to Sponsor the rights described in these Official Rules. If a participant is unable to participate in the Drawing as requested by the Sponsor, Sponsor reserves the right to deem that participant’s entry as forfeited in its entirety and disqualified. Each participant will only be eligible to be awarded one prize as defined herein.

The Drawing is subject to all applicable federal, state, and local laws, rules and regulations.

- 2 **How to Enter.** To enter the Drawing, a participant must register for a minimum of one (1) credit-based course at Miami Dade College for 2017-1 (fall term) at: (www.mdc.edu/registration) and remain enrolled in a minimum of one (1) credit-based course as of the date the Drawing. Registration for Miami Dade College credit courses for 2017-1 (fall term) constitutes one (1) entry for the Drawing (“Entry”). The odds of winning a prize (“Prize”) depend on the number of eligible participants.
- 3 **Sponsor’s Use of Entries and Related Materials.** By accepting an awarded prize, each participant agrees to and irrevocably assigns and transfers to Sponsor any and all right, title and interest that the participant has or may have in his/her Entry and all other related materials provided to Sponsor or otherwise prepared in connection with the Drawing or acceptance of a Prize in any way, which may or may not include the participant’s name, voice, image, photograph, likeness, city and state of residence and/or responses to the Drawing. Each participant agrees to take, at Sponsor’s expense, any further action (including, without limitation, execution of affidavits and other documents) reasonably requested by Sponsor to effect, perfect or confirm Sponsor’s rights as set forth in this Paragraph 3.
- 4 **Winner Selection and Verification.** The Drawing is being conducted by the Sponsor’s MDC Institutional Research department. All eligible participants will be included in the pool to be entered into a random drawing for one (1) of the four (4) \$500 Cash Prizes. MDC Institutional Research officials will generate a list of all eligible participants who registered during the Drawing Period and remain enrolled in a minimum of one (1) credit-based course as of the date the Drawing. MDC Institutional Research officials will randomly select four (4) winners from the list of all eligible participants. The drawing for the names of the Drawing Winners will be conducted on September 6, 2017 at 10:00 a.m. EST at the Sponsor’s MDC Institutional Research office, 300 N.E. 2nd Avenue, Building 5, Room 5601, Miami, Florida 33132. The four (4) Drawing Winners are subject to verification of their eligibility and compliance with the Official Rules.
- 5 **Prize Winner Notification.** Sponsor will contact the Drawing Winners by sending an email notification to the email address that the participant

provided at time of their registration and/or by phone at the phone number that the participant provided at time of their registration and by any other method. Sponsor will make three (3) attempts to contact the Drawing Winners by the method described above within one (1) business day after they were determined to be a Drawing Winner. Drawing winners must respond to the email, phone or other notification by September 11, 2017 or they shall forfeit their prize. If Sponsor is unable to reach a Drawing Winner by any of the methods described above within such time, that Drawing Winner will be disqualified. An alternate Drawing Winner will be determined by randomly selecting another winner from the names of all of other remaining eligible participants using the selection criteria and Locations described above (“Alternate Drawing Winner”). The Alternate Drawing Winner will be notified in the same manner described herein. Drawing winners must respond to the email, phone or other notification by September 15, 2017 or they shall forfeit their prize. In the event the Alternate Drawing Winner forfeit’s their prize, no other drawing will take place and the prize will not be awarded. Sponsor shall have no liability for any winner notification that is lost, intercepted, not read, or not received by a potential winner for any reason.

- 6 **Winner Supplemental Submissions:** If a participant is selected as a Drawing Winner, he/she may be required to submit the additional information (e.g. a photo, and a short bio), prior to acceptance of the Prize, for Sponsor’s use in promoting the Shark \$500 Drawing and the Drawing Winners.
- 7 **Prize.** The Drawing Winners will be awarded the following: Four (4) unique winners will each be awarded one (1) \$500 Cash Prize.
- 8 **Disqualification and Cancellation of Drawing and Events.** At any time during the Drawing, Sponsor reserves the right in its sole discretion to disqualify and eliminate any entry, Entries or other submission from a participant for any reason, including but not limited to, because Sponsor believes the entry or Entries do not comply with these Official Rules. Sponsor reserves the right to amend these Official Rules, or terminate, suspend or modify the Drawing, in its sole discretion. Sponsor reserves the right to replace and/or substitute similar prizes, regardless of value, should the Prizes specified in these Official Rules, or any portion thereof be unavailable, for any reason.
