

## **Course Description**

## CJL4064 |Corrections Administration & Law | 3.00 credits

An overall view of the nature, philosophy, operations and goals of secure and non-secure correctional institutions and programs.

## Course Competencies:

**Competency 1:** The student will describe correctional purpose, history, theory, and practice by:

- 1. Discussing differences in strict confinement, rehabilitation, and treatment
- 2. Outlining purposes of corrections
- 3. Discussing the types and stages of changes in correctional reform

**Competency 2:** The student will describe the forms of correctional sanctions and sentencing by:

- 1. Explaining the historical policies of sentencing reform
- 2. Discussing offender typologies and sentencing guidelines
- 3. Discussing the classification of offenders and related correctional facilities
- 4. Outlining correctional sanctions

**Competency 3:** The student will discuss correctional management practices by:

- 1. Analyzing the architectural design of jails and prisons
- 2. Outlining management styles utilized in correctional facilities
- 3. Describing sanctions within confinement
- 4. Describing the goals of incarceration

**Competency 4:** The student will discuss the classification of prisons by:

- 1. Exploring the impact of the prison experience on the inmate
- 2. Evaluating models of prison society
- 3. Describing prison economy and industry and its role in rehabilitation

**Competency 5:** The student will describe confinement operations describing types of prisons by:

- 1. Explaining profit industry operations
- 2. Discussing the application of rehabilitation and training
- 3. Outlining facility emergency procedures

Competency 6: The student will describe educational programs as part of confinement operations by:

- 1. Identifying and discussing available educational and recreational programs and their impact on reintegration into society
- 2. Debating the impact of job and training programs on pre-release

**Competency 7:** The student will describe correctional issues and incarceration trends, identifying issues that influence spending and operational costs of prisons and jails by:

- 1. Discussing cell size, time afforded to exercise, meals, and type of food provided to inmates
- 2. Discussing visitation issues and challenges
- 3. Researching the evolution of inmates' rights

**Competency 8:** The student will describe prison population trends by:

- 1. Discussing prison gang influence
- 2. Discussing the impact of overcrowding
- 3. Researching and discussing potential solutions to overcrowding

**Competency 9:** The student will describe inmate surveillance by:

- 1. Discussing the use of surveillance technology
- 2. Discussing inmates' restrictions as a method of control
- 3. Analyzing the design of structures

**Competency 10:** The student will discuss the elements of correctional operations by:

- 1. Defining Standard Operating Procedures
- 2. Analyzing the inmate disciplinary process
- 3. Analyzing institutional reports
- 4. Examining operational issues of funding, spending, and records maintenance
